

PARACELLA PTY LTD T/A ABBOTT STORAGE SYSTEMS - TERMS AND CONDITIONS OF TRADE

1. Definitions

- "ABBOTT" means Paracella Ptv Ltd (ATF The Kelvin Flintoff 11 Family Trust) T/A Abbott Storage Systems, its successors and assigns or any person acting on behalf of and with the authority of Paracella Pty Ltd (ATF The Kelvin Flintoff Family Trust) T/A Abbott Storage Systems.
- 12 "Customer" means the person/s buying the Goods as specified in any invoice, document or order, and if there is more than one Customer is a reference to each Customer jointly and severally.
- 'Goods" means all Goods or Services supplied by ABBOTT to the 1.3 Customer at the Customer's request from time to time (where the context so permits the terms 'Goods' or 'Services' shall be interchangeable for the other).
- "Price" means the Price payable for the Goods as agreed 14 between ABBOTT and the Customer in accordance with clause 4 below.

2. Acceptance

- The Customer is taken to have exclusively accepted and is 2.1 immediately bound, jointly and severally, by these terms and conditions if the Customer places an order for or accepts delivery of the Goods.
- These terms and conditions may only be amended with 2.2 ABBOTT's consent in writing and shall prevail to the extent of any inconsistency with any other document or agreement between the Customer and ABBOTT.

3. **Change in Control**

The Customer shall give ABBOTT not less than fourteen (14) days prior written notice of any proposed change of ownership of the Customer and/or any other change in the Customer's details (including but not limited to, changes in the Customer's name, address, contact phone or fax number/s, or business practice). The Customer shall be liable for any loss incurred by ABBOTT as a result of the Customer's failure to comply with this

Price and Payment 4. 4.1

- At ABBOTT's sole discretion the Price shall be either as indicated on any invoice provided by ABBOTT to the (a) Customer; or
- the Price as at the date of delivery of the Goods according (b) to ABBOTT's current price list; or
- ABBOTT's quoted price (subject to clause 4.2) which will be valid for the period stated in the quotation or (c)
- otherwise for a period of thirty (30) days. ABBOTT reserves the right to change the Price if a variation to 4.2 ABBOTT's quotation is requested. Any variation from the specifications (including, but not limited to, any variation as a result of additional works required due to hidden or unidentifiable difficulties or as a result of increases to the Seller in the cost of materials and labour) will be charged for on the basis of the Seller's quotation and will be shown as variations on the invoice. Payment for all variations must be made in full at their time of completion.
- At ABBOTT's sole discretion a non-refundable deposit may be 4.3 required.
- Time for payment for the Goods being of the essence, the Price 44 will be payable by the Customer on the date/s determined by ABBOTT, which may be:
 - on delivery of the Goods; (a)
 - (b)
 - before delivery of the Goods; by way of instalments/progress payments in accordance (c) with ABBOTT's payment schedule; the date specified on any invoice or other form as being (d)
 - the date for payment; or failing any notice to the contrary, the date which is (e)
 - fourteen (14) days following the date of any invoice given to the Customer by ABBOTT.
- Payment may be made by cash, cheque, bank cheque, 4.5 electronic/on-line banking, credit card (plus a surcharge of up to three percent (3%) of the Price), or by any other method as
- agreed to between the Customer and ABBOTT. Unless otherwise stated the Price does not include GST. In 4.6 addition to the Price the Customer must pay to ABBOTT an amount equal to any GST ABBOTT must pay for any supply by ABBOTT under this or any other agreement for the sale of the Goods. The Customer must pay GST, without deduction or set off of any other amounts, at the same time and on the same basis as the Customer pays the Price. In addition the Customer must pay any other taxes and duties that may be applicable in addition to the Price except where they are expressly included in the Price.

5. **Delivery of Goods**

Delivery ("Delivery") of the Goods is taken to occur at the time that.

- the Customer or the Customer's nominated carrier takes (a) possession of the Goods at ABBOTT's address; or
- ABBOTT (or ABBOTT's nominated carrier) delivers the (b) Goods to the Customer's nominated address even if the Customer is not present at the address.
- At ABBOTT's sole discretion the cost of delivery is included in 5.2 the Price.
- The Customer must take delivery by receipt or collection of the Goods whenever they are tendered for delivery. In the event 5.3 that the Customer is unable to take delivery of the Goods as arranged then ABBOTT shall be entitled to charge a reasonable fee for redelivery and/or storage.
- ABBOTT may deliver the Goods in separate instalments. Fach 5.4 separate instalment shall be invoiced and paid in accordance with the provisions in these terms and conditions. Any time or date given by ABBOTT to the Customer is an
- 5.5 estimate only. The Customer must still accept delivery of the Goods even if late and ABBOTT will not be liable for any loss or damage incurred by the Customer as a result of the delivery being late.

6. Risk

- Risk of damage to or loss of the Goods passes to the Customer 6.1 on Delivery and the Customer must insure the Goods on or before Delivery.
- If any of the Goods are damaged or destroyed following delivery but prior to ownership passing to the Customer, ABBOTT is entitled to receive all insurance proceeds payable for the Goods. The production of these terms and conditions by ABBOTT is sufficient evidence of ABBOTT's rights to receive the insurance proceeds without the need for any person dealing with ABBOTT to make further enquiries.
- If the Customer requests ABBOTT to leave Goods outside ABBOTT's premises for collection or to deliver the Goods to an unattended location then such Goods shall be left at the Customer's sole risk.
- Where ABBOTT is required to install the Goods, the Customer 6.4 warrants that the structure of the premises or equipment in or upon which these Goods are to be installed or erected is sound and will sustain the installation and work incidental thereto and ABBOTT shall not be liable for any claims, demands, losses, damages, costs and expenses howsoever caused or arising should the premises or equipment be unable to accommodate the installation.
- Unless expressly provided for in the contract, ABBOTT shall not 65 undertake or be responsible for any builder's work or other work involving alterations to the structure of any premises where works are to be undertaken by ABBOTT.
- Where the contract relates to the supply of Goods only, the Customer acknowledges and accepts that ABBOTT takes no 6.6 responsibility for the construction or set up of the Goods.

Title 7.

- 7.1 ABBOTT and the Customer agree that ownership of the Goods shall not pass until:
- the Customer has paid ABBOTT all amounts owing to (a) ABBOTT; and
- the Customer has met all of its other obligations to (b) ABBOTT.
- Receipt by ABBOTT of any form of payment other than cash 7.2 shall not be deemed to be payment until that form of payment has been honoured, cleared or recognised.
- 73
- It is further agreed that: (a) until ownership of the Goods passes to the Customer in accordance with clause 7.1 that the Customer is only bailee of the Goods and must return the Goods to ABBOTT on request.
 - the Customer holds the benefit of the Customer's (b) insurance of the Goods on trust for ABBOTT and must pay to ABBOTT the proceeds of any insurance in the event of the Goods being lost, damaged or destroyed.
 - the Customer must not sell, dispose, or otherwise part with possession of the Goods other than in the ordinary (c) course of business and for market value. If the Customer sells, disposes or parts with possession of the Goods then the Customer must hold the proceeds of any such act on trust for ABBOTT and must pay or deliver the proceeds to ABBOTT on demand.
 - (d) the Customer should not convert or process the Goods or intermix them with other goods but if the Customer does so then the Customer holds the resulting product on trust for the benefit of ABBOTT and must sell, dispose of or
 - return the resulting product to ABBOTT as it so directs. the Customer irrevocably authorises ABBOTT to enter any (e) premises where ABBOTT believes the Goods are kept and recover possession of the Goods.
 - ABBOTT may recover possession of any Goods in transit (f) whether or not delivery has occurred.

- the Customer shall not charge or grant an encumbrance (g) over the Goods nor grant nor otherwise give away any interest in the Goods while they remain the property of ABBOTT.
- ABBOTT may commence proceedings to recover the Price (h) of the Goods sold notwithstanding that ownership of the Goods has not passed to the Customer

8. Personal Property Securities Act 2009 ("PPSA")

- In this clause financing statement, financing change statement, security agreement, and security interest has the meaning given to it by the PPSA.
- Upon assenting to these terms and conditions in writing the 82 Customer acknowledges and agrees that these terms and conditions constitute a security agreement for the purposes of the PPSA and creates a security interest in all Goods that have previously been supplied and that will be supplied in the future by ABBOTT to the Customer.
- The Customer undertakes to: 8.3
 - promptly sign any further documents and/or provide any further information (such information to be complete, (a) accurate and up-to-date in all respects) which ABBOTT may reasonably require to;
 - register a financing statement or financing change (i) statement in relation to a security interest on the Personal Property Securities Register;
 - register any other document required to be (ii) registered by the PPSA; or
 - (iii) correct a defect in a statement referred to in clause 8.3(a)(i) or 8.3(a)(ii);
 - indemnify, and upon demand reimburse, ABBOTT for all (b) expenses incurred in registering a financing statement or financing change statement on the Personal Property Securities Register established by the PPSA or releasing
 - any Goods charged thereby; not register a financing change statement in respect of a (c) security interest without the prior written consent of ABBOTT:
 - not register, or permit to be registered, a financing statement or a financing change statement in relation to the Goods in favour of a third party without the prior written consent of ABBOTT:
 - immediately advise ABBOTT of any material change in its (e) business practices of selling the Goods which would result in a change in the nature of proceeds derived from such sales
- ABBOTT and the Customer agree that sections 96, 115 and 125 8.4 of the PPSA do not apply to the security agreement created by these terms and conditions.
- The Customer waives their rights to receive notices under sections 95, 118, 121(4), 130, 132(3)(d) and 132(4) of the PPSA.
- The Customer waives their rights as a grantor and/or a debtor
- under sections 142 and 143 of the PPSA. Unless otherwise agreed to in writing by ABBOTT, the Customer 8.7 waives their right to receive a verification statement in accordance with section 157 of the PPSA.
- The Customer must unconditionally ratify any actions taken by ABBOTT under clauses 8.3 to 8.5.
- Subject to any express provisions to the contrary nothing in 8.9 these terms and conditions is intended to have the effect of contracting out of any of the provisions of the PPSA.

9.

- Security and Charge In consideration of ABBOTT agreeing to supply the Goods, the 9.1 Customer charges all of its rights, title and interest (whether joint or several) in any land, realty or other assets capable of being charged, owned by the Customer either now or in the future, to secure the performance by the Customer of its obligations under these terms and conditions (including, but not limited to, the payment of any money).
- The Customer indemnifies ABBOTT from and against all ABBOTT's costs and disbursements including legal costs on a 9.2 solicitor and own client basis incurred in exercising ABBOTT's rights under this clause.
- The Customer irrevocably appoints ABBOTT and each director of ABBOTT as the Customer's true and lawful attorney/s to perform all necessary acts to give effect to the provisions of this clause 9 including, but not limited to, signing any document on the Customer's behalf.

10. Defects, Warranties and Returns, Competition and Consumer Act 2010 (CCA)

The Customer must inspect the Goods on delivery and must within seven (7) days of delivery notify ABBOTT in writing of any 10.1 evident defect/damage, shortage in quantity, or failure to comply with the description or quote. The Customer must notify any other alleged defect in the Goods as soon as reasonably possible after any such defect becomes evident. Upon such

notification the Customer must allow ABBOTT to inspect the

- 10.2 Under applicable State, Territory and Commonwealth Law (including, without limitation the CCA), certain statutory implied guarantees and warranties (including, without limitation the statutory guarantees under the CCA) may be implied into these terms and conditions (Non-Excluded Guarantees).
- ABBOTT acknowledges that nothing in these terms and 10.3 conditions purports to modify or exclude the Non-Excluded
- 10.4 Except as expressly set out in these terms and conditions or in respect of the Non-Excluded Guarantees, ABBOTT makes no warranties or other representations under these terms and conditions including but not limited to the quality or suitability of the Goods. ABBOTT's liability in respect of these warranties is limited to the fullest extent permitted by law.
- If the Customer is a consumer within the meaning of the CCA, ABBOTT's liability is limited to the extent permitted by section 10.5 64A of Schedule 2
- If ABBOTT is required to replace the Goods under this clause or 10.6 the CCA, but is unable to do so, ABBOTT may refund any money the Customer has paid for the Goods.
 - If the Customer is not a consumer within the meaning of the CCA, ABBOTT's liability for any defect or damage in the Goods is:
 - (a) limited to the value of any express warranty or warranty card provided to the Customer by ABBOTT at ABBOTT's sole discretion;
 - limited to any warranty to which ABBOTT is entitled, if (b) ABBOTT did not manufacture the Goods;
- otherwise negated absolutely. (c)Subject to this clause 10, returns will only be accepted provided that:
- the Customer has complied with the provisions of clause (a) 10.1: and
- ABBOTT has agreed that the Goods are defective; and (b)
- (c) the Goods are returned within a reasonable time at the Customer's cost (if that cost is not significant); and
- the Goods are returned in as close a condition to that in which they were delivered as is possible. Notwithstanding clauses 10.1 to 10.8 but subject to the CCA,
- 10.9 ABBOTT shall not be liable for any defect or damage which may be caused or partly caused by or arise as a result of:
 - the Customer failing to properly maintain or store any (a) Goods; the Customer using the Goods for any purpose other than (b)
 - that for which they were designed;
 - the Customer continuing the use of any Goods after any defect became apparent or should have become apparent to a reasonably prudent operator or user;
 - the Customer failing to follow any instructions or guidelines provided by ABBOTT; (d)
- (e) fair wear and tear, any accident, or act of God. 10.10 In the case of second hand Goods, unless the Customer is a consumer under the CCA, the Customer acknowledges that it has had full opportunity to inspect the second hand Goods prior to delivery and accepts them with all faults and that to the extent permitted by law no warranty is given by ABBOTT as to the quality or suitability for any purpose and any implied warranty, statutory or otherwise, is expressly excluded. The Customer acknowledges and agrees that ABBOTT has agreed to provide the Customer with the second hand Goods and calculated the Price of the second hand Goods in reliance of this clause 10 10
- 10.11 ABBOTT may in its absolute discretion accept non-defective Goods for return in which case ABBOTT may require the Customer to pay handling fees of up to ten percent (10%) of the value of the returned Goods plus any freight costs.
- 10.12 Notwithstanding anything contained in this clause if ABBOTT is required by a law to accept a return then ABBOTT will only accept a return on the conditions imposed by that law.

11. Intellectual Property

- Where ABBOTT has designed, drawn or developed Goods for the 11.1 Customer, then the copyright in any designs and drawings and
- documents shall remain the property of ABBOTT. The Customer warrants that all designs, specifications or instructions given to ABBOTT will not cause ABBOTT to infringe any patent, registered design or trademark in the execution of the Customer's order and the Customer agrees to indemnify ABBOTT against any action taken by a third party against ABBOTT in respect of any such infringement.
- 11.3 The Customer agrees that ABBOTT may (at no cost) use for the purposes of marketing or entry into any competition, any documents, designs, drawings or Goods which ABBOTT has created for the Customer.

- **12.** Default and Consequences of Default 12.1 Interest on overdue invoices shall accrue daily from the date when payment becomes due, until the date of payment, at a rate of two and a half percent (2.5%) per calendar month (and at ABBOTT's sole discretion such interest shall compound monthly at such a rate) after as well as before any judgment.
- If the Customer owes ABBOTT any money the Customer shall indemnify ABBOTT from and against all costs and 12.2 disbursements incurred by ABBOTT in recovering the debt (including but not limited to internal administration fees, legal

costs on a solicitor and own client basis, ABBOTT's collection agency costs, and bank dishonour fees).

- Without prejudice to any other remedies ABBOTT may have, if at any time the Customer is in breach of any obligation (including those relating to payment) under these terms and conditions ABBOTT may suspend or terminate the supply of Goods to the Customer. ABBOTT will not be liable to the Customer for any loss or damage the Customer suffers because ABBOTT has exercised its rights under this clause. Without prejudice to ABBOTT's other remedies at law ABBOTT
- 12.4 shall be entitled to cancel all or any part of any order of the Customer which remains unfulfilled and all amounts owing to ABBOTT shall, whether or not due for payment, become
 - immediately payable if: (a) any money payable to ABBOTT becomes overdue, or in ABBOTT's opinion the Customer will be unable to make a payment when it falls due;
 - the Customer becomes insolvent, convenes a meeting (b) with its creditors or proposes or enters into an arrangement with creditors, or makes an assignment for the benefit of its creditors; or
 - a receiver, manager, liquidator (provisional or otherwise) (c) or similar person is appointed in respect of the Customer or any asset of the Customer.

13. Cancellation

- ABBOTT may cancel any contract to which these terms and conditions apply or cancel delivery of Goods at any time before the Goods are delivered by giving written notice to the Customer. On giving such notice ABBOTT shall repay to the Customer any money paid by the Customer for the Goods. ABBOTT shall not be liable for any loss or damage whatsoever arising from such cancellation.
- 13.2 In the event that the Customer cancels delivery of Goods the Customer shall be liable for any and all loss incurred (whether direct or indirect) by ABBOTT as a direct result of the
- cancellation (including, but not limited to, any loss of profits). Cancellation of orders for Goods made to the Customer's specifications, or for non-stocklist items, will definitely not be accepted once production has commenced, or an order has been placed.

14. Privacy Act 1988

- 14 1 The Customer agrees for ABBOTT to obtain from a credit reporting agency a credit report containing personal credit information about the Customer in relation to credit provided by ABBOTT.
- The Customer agrees that ABBOTT may exchange information about the Customer with those credit providers either named as trade referees by the Customer or named in a consumer credit report issued by a credit reporting agency for the following purposes:
 - to assess an application by the Customer; and/or (a) to notify other credit providers of a default by the (b)
 - Customer; and/or to exchange information with other credit providers as to (c) the status of this credit account, where the Customer is in default with other credit providers; and/or
 - to assess the creditworthiness of the Customer (d) The Customer understands that the information exchanged can include anything about the Customer's creditworthiness, credit standing, credit history or credit capacity that credit providers are allowed to exchange under the Privacy Act 1988.
- 14.3 The Customer consents to ABBOTT being given a consumer credit report to collect overdue payment on commercial credit (Section 18K(1)(h) Privacy Act 1988).
- The Customer agrees that personal credit information provided 14.4 may be used and retained by ABBOTT for the following purposes (and for other purposes as shall be agreed between the Customer and ABBOTT or required by law from time to time):
 - the provision of Goods: and/or (a)
 - the marketing of Goods by ABBOTT, its agents or (b) distributors; and/or
 - analysing, verifying and/or checking the Customer's (c) credit, payment and/or status in relation to the provision of Goods: and/or
 - processing of any payment instructions, direct debit (d) facilities and/or credit facilities requested by the Customer; and/or
 - enabling the daily operation of Customer's account (e) and/or the collection of amounts outstanding in the Customer's account in relation to the Goods
- 14.5 ABBOTT may give information about the Customer to a credit reporting agency for the following purposes:
 - to obtain a consumer credit report about the Customer: (a) allow the credit reporting agency to create or maintain a (b) credit information file containing information about the Customer.
- 14.6 The information given to the credit reporting agency may
 - include: personal particulars (the Customer's name, sex, address (a) previous addresses, date of birth, name of employer and driver's licence number);
 - details concerning the Customer's application for credit or (b) commercial credit and the amount requested;

- advice that ABBOTT is a current credit provider to the (c)
- (d) advice of any overdue accounts, loan repayments, and/or any outstanding monies owing which are overdue by more than sixty (60) days, and for which debt collection action has been started;
- that the Customer's overdue accounts, loan repayments (e) and/or any outstanding monies are no longer overdue in respect of any default that has been listed
- information that, in the opinion of ABBOTT, the Customer (f) has committed a serious credit infringement (that is, fraudulently or shown an intention not to comply with the Customer's credit obligations);
- advice that cheques drawn by the Customer for one hundred dollars (\$100) or more, have been dishonoured (q) more than once;
- that credit provided to the Customer by ABBOTT has been (h) paid or otherwise discharged.

15. Unpaid Seller's Rights

- Where the Customer has left any item with ABBOTT for repair, modification, exchange or for ABBOTT to perform any other 15.1 service in relation to the item and ABBOTT has not received or been tendered the whole of any moneys owing to it by the Customer, ABBOTT shall have, until all moneys owing to ABBOTT are paid:
- a lien on the item; and (a)
- the right to retain or sell the item, such sale to be undertaken in (b) accordance with any legislation applicable to the sale or disposal of uncollected goods.
- The lien of ABBOTT shall continue despite the commencement 15.2 of proceedings, or judgment for any moneys owing to ABBOTT having been obtained against the Customer.

16. Compliance with Laws

- The Customer and ABBOTT shall comply with the provisions of 16.1 all statutes, regulations and bylaws of government, local and other public authorities that may be applicable to the works. The Customer shall obtain (at the expense of the Customer) all
- licenses and approvals that may be required for the works. The Customer agrees that the site will comply with any
- occupational health and safety laws relating to building/construction sites and any other relevant safety standards or legislation.

17. Construction Contracts Act 2004

- At ABBOTT's sole discretion, if there are any disputes or claims for unpaid Goods and/or Services then the provisions of the Construction Contracts Act 2004 may apply. Nothing in this agreement is intended to have the affect of
- 17.2 contracting out of any provisions of the Construction Contracts Act 2004 of Western Australia, except to the extent permitted by the Act where applicable.

18. General

- The failure by ABBOTT to enforce any provision of these terms and conditions shall not be treated as a waiver of that 18.1 provision, nor shall it affect ABBOTT's right to subsequently enforce that provision. If any provision of these terms and conditions shall be invalid, void, illegal or unenforceable the validity, existence, legality and enforceability of the remaining provisions shall not be affected, prejudiced or impaired
- These terms and conditions and any contract to which they apply shall be governed by the laws of the state in which 18.2 ABBOTT has its principal place of business, and are subject to the jurisdiction of the courts in that state.
- Subject to clause 10 ABBOTT shall be under no liability 18.3 whatsoever to the Customer for any indirect and/or consequential loss and/or expense (including loss of profit) suffered by the Customer arising out of a breach by ABBOTT of these terms and conditions (alternatively ABBOTT's liability shall be limited to damages which under no circumstances shall exceed the Price of the Goods).
- The Customer shall not be entitled to set off against, or deduct from the Price, any sums owed or claimed to be owed to the 18.4 Customer by ABBOTT nor to withhold payment of any invoice because part of that invoice is in dispute.
- ABBOTT may license or sub-contract all or any part of its rights and obligations without the Customer's consent.
- The Customer agrees that ABBOTT may amend these terms and conditions at any time. If ABBOTT makes a change to these terms and conditions, then that change will take effect from the date on which ABBOTT notifies the Customer of such change. The Customer will be taken to have accepted such changes if the Customer makes a further request for ABBOTT to provide Goods to the Customer.
- Neither party shall be liable for any default due to any act of God, war, terrorism, strike, lock-out, industrial action, fire, flood, storm or other event beyond the reasonable control of either party.
- The Customer warrants that it has the power to enter into this agreement and has obtained all necessary authorisations to allow it to do so, it is not insolvent and that this agreement creates binding and valid legal obligations on it.
